ARTICLES OF MERGER

Pursuant to New Hampshire Revised Statutes Annotated Chapter 287 Voluntary Corporations and Associations, the undersigned corporations adopt the following Articles of Merger for the purpose of merging them into one of such corporations:

FIRST: The plan of Merger attached hereto as Exhibit A was approved by each of the undersigned corporations.

SECOND: As to each of the undersigned corporations, the plan of Merger was adopted in the following manner.

The plan of Merger was adopted by the Gilmanton Corner Fire Department/Peaked Hill Fire Department and the Gilmanton Iron Works Fire Department at a meeting of all members held on December 5, 1988. The members present were unanimous in their vote to join the organization into one.

Through the merger the name of the organization is changed to the Gilmanton Fireman's Association, effective June 4, 1990.

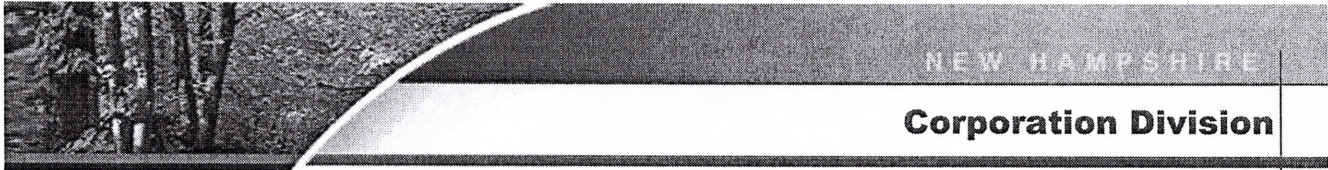
Exhibit A
Plan of Merger

Plan of Merger made this 5th day of December 1988, between the Gilmanton Corner Fire Department, Gilmanton New Hampshire, (Hereinafter "Surviving Corporation"), and the Peaked Hill Fire Department, Gilmanton New Hampshire, and the Gilmanton Iron Works Fire Department, Gilmanton IW New Hampshire, (hereinafter "Merged Corporations").

WHEREAS, the officers and members of the Merged Corporations and the Surviving Corporation deem it advisable and generally to the advantage and welfare of the respective corporations if the operations of the Merged Corporation were merged into and consolidated with those of the Surviving Corporation under and pursuant to 292:7 of the Revised Statutes Annotated of New Hampshire.

NOW THEREFORE, in consideration of the bylaws, and mutual agreements herein contained, and by the mutual benefits herein provided, the parties hereto do hereby agree to the merger and consolidation of the corporations into a single corporation, as follows:

1. Merger. Upon the effective date, the Merged Corporation merged into the Surviving Corporation.
2. Effective Date. The Agreement of Merger did become effective upon compliance with the laws of the State of New Hampshire.
3. Surviving Corporation. The Surviving Corporation shall survive the merger herein contemplated and shall continue to be governed by the laws of the State of New Hampshire, but the separate corporate existence of the Merged Corporations shall cease forthwith upon the effective date. The name of the Surviving Corporation was the Gilmanton Corner Fire Department, and shall effective June 4, 1990 be known to all as the Gilmanton Fireman's Association
4. Objects and Purpose. The objects and purposes of the Surviving Corporation shall be to raise and appropriate private funds for the purpose of charitable support of the Gilmanton Fire Department. In the Furtherance of this objective the Association may purchase, hire, rent, or contract the necessary tools, equipment, vehicles, buildings, or services that are deemed necessary by the members to support the overall operation of the Gilmanton Fire Department.
5. By-Laws. The By-laws of the Gilmanton Fireman's Association shall be those which have been duly adopted according to applicable law and the provisions thereof.
