Moved, seconded and carried that fire equip be used for fires only, after Asst. Chief Barlow said he had been asked to use dept. pump to pump out well.

Special meeting: discussion of by laws and possible changes needed.

- 12/04/1956 According to Art VII Section 3 of our Bylaws, all monies allotted to, donated to, or earned by the Peaked Hill Fire Department are governed by the same restrictions and a full account of such monies should be made in the annual town report

12/13/1956 Special Meeting. Secretary's report in part, "lawyers interpretation" monies had to be dispensed in the interests of fire protection only. <u>No</u> donations, contributions, or floral gifts are possible out of this money.
