*God with the Aged:* A Sermon preached to the First Church, Jan. 7. 1849, the Sunday after the death of Hon. Peter C. Brooks, by N. L. FROTHINGHAM, Pastor of the Church. PRIVATE. Boston: Printed by John Wilson, 21 School Street. 1849. 8vo. pp. 15.

Such is the title of an affectionate tribute to the memory of the aged parishioner and honored father-in-law, by one whose singular good fortune it was to stand in the two-fold relation of pastor and son to the deceased.

The *JOSE. PETER CHANDLER BROOKS*, the son of Rev. Edward Brooks and Abigail Brown, his wife, was born at North Yarmouth, in the State of Maine, Jan. 6, 1767. His father, a native of Medford, Mass., where he was born, (according to the College Records) Oct. 31, 1734, graduated at Harvard College in 1757, sustained the office of Librarian from 1738 to 1760, and, upon the decease of Rev. Nicholas Loring, in July, 1763, received an unanimous call to become his successor in the Ministry at North Yarmouth. The invitation being accepted, he was ordained July 4, 1764, on which occasion it is stated that "one hundred and sixteen dollars and sixty-six cents were expended for an Ordination dinner; and the sumptuous entertainment then had been provided in town, on the 4th of July, since the celebration of Independence." But, "this auspicious morning, Mr. Brooks's ministerial life, as it might be said, was soon clouded by disaffection and discontent," and in March, 1769, he was obliged to have been accented to his friends, "that his enemies in North Yarmouth had done him more violence than his friends." His wife was Abigail, the daughter of Rev. John Broome of Hallowell, the son of Rev. Richard Cotton, of Boston. Mr. Brooks died in 1781. His great-granddaughter of the Rev. Richard John Cotton, of Boston. Mr. Brooks died in 1781. Brooks, of Concord — by his second wife, Ann, who was the daughter of Capt. Thomas Brooks, a man of some considerable note in Concord, where he died July 21, (or 22), 1667. His wife Grace died May 12, 1664.

His of the Hon. Peter C. Brooks we will say a few words, mostly in the language of an ordinary which has appeared in the public papers. He was, in early life, a distinguished member of the business community. While yet a boy he was initiated into the various laws, and operations of insurance, and when he became a man, opened an Insurance Office, in Boston, upon his own responsibility; and it was now, as an underwriter — generally on marine risks — that he laid the foundation of that wealth for which he was after.

JOSEPH, son of Benjamin and Sarah, lived at Ridgfield, upon the homestead. He d. Dec. 1794, leaving several children. His eldest son Samuel, who was a highly esteemed and useful citizen, died 27 March, 1836. His widow lived to the age of 90. Their eldest son, John, a banker in New York, died in 1834, and was succeeded in his business by his son John, a talented literary gentleman, who was President of the Mercantile Library Association. At his death, the Association erected a tablet to his memory. Another son died in the West Indies, of consumption. The third, who is a banker in Wall St. New York, mar. Sarah A. Weston, and has several children. The youngest mar. Julia Morris, a descendant of Robert Morris.

NATHAN, the second son of Joseph and Joanna, was b. Oct. 1764. He married and settled at Ridgfield, where he d. 27 Nov. 1828, leaving several children. Russel, the eldest, b. 5 Mar. 1792, is a merchant. He has pursued a lucrative business in Alabama and other Southern States, and is now located in New York city, the senior partner in the firm R. & D. M. Stebbins. He mar. in 1828, Ann Eliza Davis, and has had children; Mary E.; Julia R.; John D.; and Emma C.; James, the second son of Nathan, d. 10 Nov. 1818, at Blakely, Ala. Charles, the third son, b. 4 April, 1797, was a merchant in New York. He mar. Jane Bliss, and d. 12 April, 1835. Nathan G., the fourth son, b. 28 May, 1802, mar. Ann Eliza Kniffin, and resides near Buffalo, N. Y. David M., the fifth and youngest son, b. 11 May, 1810, mar. Julia Ann Cliff, of Carmel, N. Y. He is a merchant in New York city.

JOSEPH, the third son of Joseph and Joanna, b. 30 Sept. 1766, d. 1849, mar. Abigail Hines, and had several children. There were other children of Joseph's son, who had families.

JOSEPH STENNIS\*, and his son Joseph<sup>4</sup>, the third and fourth of the name in the pedigree, were large dealers in beef cattle at Springfield. The "big ox," which on some patriotic occasion previous to the revolution was decorated with ribbons and flags, and after being paraded through the streets of Boston, was roasted whole, in the presence of thousands of spectators, is supposed to have been fattened in their stalls. At the time of Arnold's expedition to Canada, it became necessary to procure specie, in order to purchase provision for the troops after entering the British territory. Agents were sent from Boston to procure it, and among other places they visited Springfield, where resided the two Joseph Stebbins, father and son. These persons probably handled more hard money in the purchase and sale of cattle, than any other two individuals in western Massachusetts. Their patriotism was not appealed to in vain. One thousand dollars in specie was taken from the "old oaken chest," at the foot of the bed, and the sumo amount in Continental money deposited in its place. The money soon depreciated in value, until it became almost worthless. They had the consciousness, however, of having assisted their country in its hour of need. Had not the two Josephs been "a man of substance," their business would have been ruined.

## BROOKS OF CHESHIRE, CT.

[Communicated by Mr. ELIHU YALE, of Cheshire, Ct.]

The Genealogy of the families of Henry and John Brooks, who emigrated from Cheshire, England, about A.D. 1660, and from whom the present town of Cheshire, Ct., received its name. It originally belonged to the town of Wallingford.

The following Record of Births, Marriages and Deaths was copied from the Town Records of Wallingford: Hannah, daughter of John Brooks, b. 9th Feb. 1663; Ruth, b. 7th Feb. 1665; Sophia Elizabeth, b. 6th Dec. 1668. Matthew Ford, and Mary Brooks, were married by me, William Jones, Justice of the Peace, 12th July, 1674. Henry Brooks, and Hannah Blakely, were married by me, Wm. Jones, Justice of the Peace, 21st Dec. 1676. Thomas, son of Henry Brooks, b. 27th Mar. 1673. Benjamin Robins and Sarah Brooks, were married 29th Aug. 1687. William Baldwin and Ruth Brooks, were married by William Jones, 24 July, 1688. Thomas Brooks and Martha Hotchkiss, married by John Alling, 25th Mar. 1702.

From 1685 down to 1704, John and Henry Brooks were on the list of the proprietors of Wallingford. In 1713, Henry Brooks' name continued on the list, but John's had disappeared, and it is supposed that he and his family removed to Fairfield county.

Dear Sir:—In the last number of your Register, page 126, is the following sentence: "Antinomians and all other phrenetics, delays of the times, &c., &c." Mr. Gage, in his history of Kowley, makes the same mistake precisely. It should be, "Antinomians and all other phrenetic [*?*] *delays* of the times, &c."

Your extract from the Mass. Spy, concerning Dr. William Boucher Leonard, will enable you to correct a mistake in No. 10, of the Register, April, 1849, page 137. Dr. S. P. Hildreth says, that Dr. W. B. Leonard, "about the year 1791, decided on removing to the United States." This should be 1781. Dr. H. says that Dr. Leonard came to America about the year 1797. This is wrong. He was in Newburyport in 1793, as the following advertisement will show.

"Dr. Leonard respectfully acquaints the inhabitants of this Town and Environs, that after an extensive Practice by sea and land, and in the many Hospitals in London and other parts of Europe, has been a Practitioner in Physic and Surgery, Midwifery, &c., &c. upwards of 35 years, and with good success, in many great operations; and it has so happened that kind Providence has enabled him to spring out of the iron chains of tyranny, horror, devastation and murder, to the only summit of Liberty under the sun, and where the diadem of a despot was hurled down to the bottomless abyss, and where I hope even the shadow of the life will never more appear. Mr. L. intreats for a share in the favors of his fellow citizens, and he humbly hopes that his abilities and experience, with the faithful discharge of his duty to the lives and limbs of his employers, will commend him to future favors, who solicit no longer than his character is deserving of the same, which will ever be acknowledged with gratitude by their most obliged and very humble servant,

**THE GREAT SEAL OF MARYLAND.**—The following joint resolutions were adopted by the Maryland General Assembly at its last session:

"Whereas, Senate Joint Resolution No. 9, in relation to the Great Seal of the State, passed by the General Assembly at its session in 1874, instructing the Governor to have the Great Seal of the State so altered that it should conform to the arms of Lord Baltimore as represented on the title page of Bacon's Laws of Maryland, printed in 1753 by Jonas Green, was passed under the impression that the said representation was accurate; and

"Whereas, Investigation has shown that said representation of the arms of Lord Baltimore is imperfect; and

"Whereas, A complete and accurate description of the Seal of the Province is to be found in the Commission of Cecilus, Lord Baron of Baltimore, that accompanied the said Seal when sent to the Province in 1618; therefore,

"First, *Be it resolved by the General Assembly of Maryland, That Senate Joint Resolution No. 9, in relation to the Great Seal of the State, passed by the General Assembly at its session in 1874, be, and the same is hereby, rescinded.*

"Second. *And be it further resolved, That the Governor of the Province is hereby authorized and empowered to have the Great Seal of the State altered so that it shall bear the arms of Maryland as represented upon the Seal furnished in the Province in 1618 by Cecilus, Lord Baron of Baltimore; which arms are described as follows, namely: Quarterly, first and fourth pale of six or and sable, a bend counter-changed; second and third quarterly argent and gules, a cross bottony counter-changed; Crest (which is placed upon a helmet showing five bars, over a Count-palantine's coronet) on a ducal coronet proper, two pennons, dexter or, the other sable; a staves gules; Motto, *Fatti mespet, parole fenne.* Supporters, a plowman and a fisherman proper; a Mantle doubled with ermine, surrounding the arms and supporters: Upon a border encircling the Seal shall be engraven this legend: *Scuto bonae voluntatis tunc coronati nos.* The diameter of the Seal shall be three inches."*

It was deemed proper to return to the seal as sent to the Province by Cecilus, Lord Baltimore, in 1618. An effort to do so was made some years ago, but the great seal was omitted and an eagle substituted.

The commission for the Great Seal is to be found in the second volume of *Bosman's History of Maryland.*

**RESTORING OLD DEEDS.**—For restoring old deeds, I have found it best to employ a strong solution of tannic acid brushed over the writing with a camel-hair pencil. Tincture of nutgalls as recommended in the *Register*, xxx. 103, is objectionable, as it stains the document. The parchment ought to be stretched with drawings-pins, and afterwards put to press between blotting-paper. Sometimes the dose of tannic acid may have to be repeated. It will be found that thus pressing the parchment will take away all creases.

## NECROLOGY OF THE NEW-ENGLAND HISTORIC GENEALOGICAL SOCIETY.

Prepared by the Historiographer, Rev. GEORGE M. ADAMS, D.D., of Andover, Mass.

These sketches are abstracts of the Necrologies prepared by the Historiographer or under his direction and printed annually in the Proceedings of the Society. The Necrologies themselves are of necessity brief, because the space that can be appropriated is limited. Materials for still more extended memoirs are preserved in the Society's archives, and will be available for use in preparing the "Memorial Biographies," of which five volumes have been issued and a sixth volume is in preparation. The income from the Towne Memorial Fund is devoted to the publication of these volumes.

Mr. LEWIS BROOKS BAILEY, who became a member of the Historic Genealogical Society 6 March, 1867, died 18 Nov., 1888, at nearly fifty-eight years of age. Although born in Brooklyn, New York, and whose father was a Worcester County man, he may be considered as having been a Boston boy and man. His parents were Lewis Bailey, born in Northboro' Jan. 2, 1792, and Mary (Hall) Bailey of Boston, born Sept. 18, 1798. Mr. Bailey was descended remotely from Thomas Bailey, the emigrant settler at Weymouth, by his son John, and grandson John of Seltuate, and Benjamin, son of the latter, who settled in Marlboro', Worcester County, and there by Col. Silas, Sen., Major Silas, Jr., and Lewis Bailey of Northboro'.

Mary Hall of Boston was the daughter of Joshua and Elizabeth (Secomb) Hall. Joshua Hall was the son of Joseph and Abigail (Brooks) Hall; Elizabeth Secomb was the daughter of Joseph and Ruth (Brooks) Hall. These sisters, Abigail and Ruth, daughters of Caleb Brooks of Medford, were thus the paternal and maternal grandmothers of Mary (Hall) Bailey. Lewis Bailey and Mary Hall were married May 19, 1825, and soon were residing in Philadelphia, where Mr. Bailey's business was that of a commission merchant in company with Mr. Henry Willis of Boston. After leaving Philadelphia, and during a short residence of the family in Brooklyn, N. Y., Mr. Lewis Brooks Bailey was born there Feb. 6, 1831. Within a short time after this the family were living in Boston, where Lewis Bailey, the father, died Jan. 6, 1834 leaving four young children to the care of the mother.

Mr. Joshua Hall, who died in 1812, willed his property to his wife Elizabeth (Secomb) for her use during her natural life, and upon her death to be divided equally between his daughters Elizabeth and Mary. It was under the care of their mother and grandmother Elizabeth, that these children passed their school days. Living on Bowdoin Street, Lewis B. attended the Mayhew School there, in Church Street. Afterwards he attended the Channing Hall Private school, and the English High School of the city. The latter place he left to go into the counting room of Messrs. (Henry) Wainwright & (Severell) Young, shipping merchants on Central Wharf. Leaving this place at his maturity, he spent the next nine years as a clerk for Mr. James S. Amory, and at the same time and place for Mr. Thomas C. Linzale, who were treasurers, respectively, of the Nashua & Jackson and of the Lancaster and other mills. Upon the death of Mr. Linzale, he left this place to take care of his mother's property. His grandmother, who had married Mr. John Baker in her widow-

hood, again a widow, died in 1847, willing all her first husband's property, as he desired, to his daughter Mary H. Bailey, Elizabeth the other daughter having deceased.

Mary H. Bailey, the mother, died Oct. 15, 1889.

Of the children, Miss Elizabeth H. Bailey is the only one now living. Joshua, a brother, was for years an invalid. A sister, the youngest of the four children, died Aug. 15, 1883.

Mr. Lewis B. Bailey married, April 11, 1861, Miss Anna Lawrence Hamilton of St. Louis. He died in 1888, and was buried at Copp's Hill old ground cemetery, as were his parents before him, and others of the family, by rights of the Hall's acquired property, last century. This is mentioned because of the very important births now within the city limits.

The Hall's had been for two generations, or more, associated with the Brattle Street Church. Mr. Joseph Hall, the grandfather, in his will speaks of his pew in Mr. Thoburn's church.—Brattle Street, and in the inventory of the property of our Joshua Hall, the father, is enumerated a pew in the Brattle Street Church. In 1825, in this church than Mr. Silas Bailey and Mary Hall were married May 19, 1825, by Rev. John G. Fairley, then pastor.

JOHN LOWELL, A. M., LL. D., a resident member, elected Dec. 2, 1891, was born in Boston, October 18, 1821, and died in Brookline, May 14, 1897. He was one of the most distinguished jurists in New England, and came from a family that has been eminent in the law and in the defence of human rights ever since the second John Lowell, when a delegate to the convention that framed the constitution of Massachusetts, insisted upon the incorporation therein of the clause—"all men are born free and equal." The subject of this notice was the son of John Amory Lowell, a Boston merchant, and the grandson of John Lowell Jr., who founded and endowed the Lowell Institute in Boston.

Justice Lowell was educated at Harvard College, from which he graduated in the class of 1843. He studied law in the Harvard Law School and in the office of Charles F. & C. W. Loring, and in 1846 was admitted to the Suffolk Bar. In 1853, he was made judge of the District Court of the United States by President Lincoln; and thirteen years later (Dec. 16, 1878) he was appointed by President Hayes Justice of the Circuit Court for the first circuit.

In May, 1881, he resigned, and returned to general practice, with offices in Boston. At a meeting of the trustees of the Peabody Fund, in New York, Sept. 25, 1895, he was elected a member of the Board, to take the place of Hon. Robert C. Winthrop, who died Nov. 16, 1894.

Justice Lowell married, May 19, 1853, Miss Lucy B. Emerson, daughter of George B. Emerson, J. L. D., and Olivia (Buckminster) Emerson. They had two sons and two daughters: John Lowell Jr., now a member of the Suffolk Bar; James Arnold, graduate of Harvard College, 1894; Lucy Buckminster, and Susan, now Mrs. William H. Aspinwall.

*Note.*—In the memoir of Justice Lowell in the Annual Proceedings of the Society, page 94, both the place to which he was elected and the date are wrong. Lines 19 and 20 should read: Sept. 25, 1895. Justice Lowell was elected a member of the Board of Trustees of the Peabody Fund, to take the place of Hon. Robert C. Winthrop.

FREDERICK DAWSON STONE, J. L. D., was born in Philadelphia, April 8, 1841, and died in Germantown, August 12, 1897. His grandfather, Charles Stone, came from England to Pennsylvania in 1795. John Stone, son of Charles, was a successful merchant in Philadelphia, and was the father of Frederick Dawson Young Stone received his education at the Union Academy, and then entered the counting house of his older brothers.

During the War of the Rebellion he enlisted in D. Company, Gray Reserve (now the famous Fifth Regiment), and was present at the fight at Carlisle and several minor skirmishes, in all of which he distinguished himself by merited bravery. At the close of the war he returned to mercantile life, in which he continued until shortly before his election to the trusteeship of the Historical Society of Pennsylvania, in 1876. This latter position he continued to occupy until his death. He received the degree of doctor of letters from the University

Hierbert Parker attended private schools in Philadelphia and studied under tutors. He entered Harvard College with the Class of 1878, but because of sickness was obliged to leave in his senior year. In 1890 Harvard gave him the degree of Bachelor of Arts, as of 1878; and in 1905 he received the honorary degree of Doctor of Laws from Tufts College.

On regaining his health, he studied law in the office of Hon. George Frisbie Hoar in Worcester. After a year of travel in Europe he completed his study and in 1883 was admitted to the Worcester County bar, and went to Washington, D. C., as private secretary to Senator Hoar and as clerk of the Senatorial committee on privileges and elections. In 1884 he returned to Worcester and opened a law office. The following year he entered partnership with Hon. John W. Corcoran at Clinton, Mass., which was dissolved in 1891, and in 1892 he became a member of the firm of Norcross, Baker & Parker at Fitchburg, Mass. Again ill health forced him to give up all active work and he withdrew from the firm. Later he practiced his profession alone.

In 1886 he was appointed an associate justice of the Second District Court of Eastern Worcester, and the following year was made assistant district attorney of the Middle District of Massachusetts. In 1895 Governor Greenhalge appointed him district attorney to fill the unexpired term of Hon. Francis A. Gaskill, who had been elected to the position of associate justice of the Supreme Court. The following year he was elected for a term of three years to 1 January 1899. He declined a re-election.

He was elected Attorney General of the Commonwealth from 1902 to 1906 and he also served as delegate to the Massachusetts Constitutional Convention held at Boston from 1917 to 1919.

As a trial lawyer he was outstanding. During his terms of office he tried the Clark Hatch forgery case, the Lilla Hoyle murder case, and the famous Charles L. Tucker murder case.

An ardent Republican, he served for many years as a member of the Lancaster Republican town committee, and in 1897 and 1898 was a member of the Republican State central committee. He was also a member of the Republican Congressional, Senatorial, County, and Representative District committees. He served, too, as a member of the Lancaster School Committee and as treasurer of the Worcester County Law Library Association.

A great lover of nature, especially of birds and wild flowers, he had a bird sanctuary near his home and grew wild flowers in their habitat.

He was a director of the State Mutual Life Insurance Company of Worcester and president of the board of trustees of Clark College and Clark University, and served as president of the board of trustees of the Public Reservations of Massachusetts and as chairman of the Massachusetts Bay Colony Yereuntary Committee in 1860.

Among the societies of which he was a member were the American Academy of Arts and Sciences (fellow), the American Bar Association (ex-president), the Worcester County Bar Association (ex-president), the Bar Association of the City of Boston (ex-president), the Medico-Legal Society of Massachusetts, the Sentinels of the Republic (director), the National Association of Audubon Societies, the Massachusetts Audubon Society, the American Geological Society, the American Museum of Natural History, the Boston Society of Natural History, the New York Zoological Society, the American Ornithologists Union (associate member), and the Town Club of Boston (ex-president). He was a member of the Unitarian Church.

He married at Lowell, Mass., 22 September 1886, Mary Carney Vose, daughter of Lieut. Josiah H. Vose, who, with five children, (George Alanson Parker, A.B. (Harvard), 1910), of Boston, Haven Parker, A.B. (Harvard, 1922), L.L.B. (*ibid.*, 1925), of Cambridge, Mass., Katharine Vose Parker, Mrs. Thorvald Solteich Ross (with three) of Cambridge, Mrs. George Parsons Milmer (Mary Carney Parker), A.B. (Princeton, 1926), of Lakeville, Conn., and Harriet Felton Parker (A.B. (Irvine Mawr, 1927), of South Lancaster, survives him.

It has also been reported to the Society that certain paper salesmen have been telling members of the Society who were seeking durable paper for their publications that the paper used in this periodical is "one hundred per cent wood."

For more than fifty years the paper used for this magazine has been made to order by the same manufacturer, and since 1907 it has been made on the Society's formula and watermarked "N. E. H. G. S. Standard." Sample sheets, selected at random, have been examined by a competent chemist, whose certificates have shown that the paper complies with the requirements of the formula. This formula is in substantial agreement with the recommendations of the Committee on Deterioration of Paper, appointed by the Society for the Encouragement of Arts, Manufactures & Commerce, whose report (London, 1898) shows an exhaustive study of the subject. The leading German, English, and American chemists who have made a study of the manufacture of paper believe that paper properly made on such specifications will prove sufficiently lasting for publications of permanent value. This Society requires not less than 75% rag fibre, not over 25% wood fibre, freedom from all but the most trace of chemicals used in the manufacture, and not over 10% clay filler.
