Dear Sir:


This list of persons who were inducted into, or enlisted, or commissioned, in the Armed Forces of the United States; who served therein subsequent to December 7, 1941, and who, prior to the date first given above, upon entry into the Armed Forces indicated the above-named community as their home address, was compiled from records of the Selective Service Local Board having jurisdiction over the named community.

It is not a complete list of all those who entered the armed forces from the community but includes all of those concerning whom official notice has been furnished by the Armed Forces. Not included in the list are persons whose age at time of entry upon service was less than or in excess of the age limits established by law and military regulation effective at the time, nor does it include the names of women who have served or are serving as members of the WAC, WAVES, Marines, or SPARS. The list includes the names of a few, but not all, of the members of the Army and Navy Nurse Corps credited to New Hampshire.

In every instance, such omissions from the list are accounted for by the fact that the appropriate branch of the armed forces has not reported and is not required to report, such information to the Selective Service System.

It is possible that there are included in this list the names of members of the Officers Reserve Corps who have not been called into active military service. The local authorities should make every effort to see that such names are removed.

Whenever the Selective Service System in New Hampshire has received official notice that the discharge of any person was other than honorable, the name of the person has been omitted from the list. However, there is no assurance that some of those listed herein may not in future be discharged from the service otherwise than honorably. When, as, and if such discharges are granted, notification will be given the municipal authority which requested and has received this list.

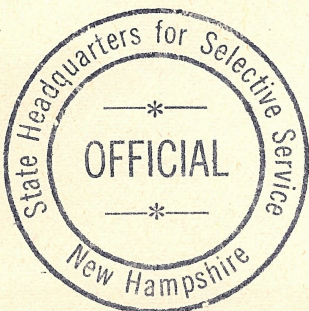

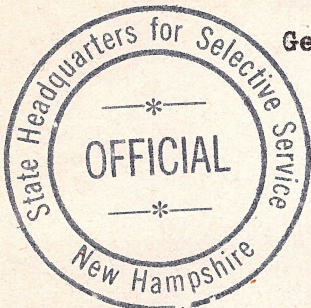

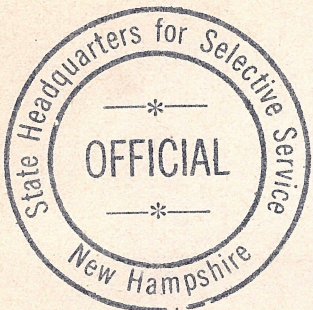
