Mother, 65, Finds Son Dead After 4-Mile Woods Hike

GILMANTON — When her 26-year-old son failed to return from a rabbit-hunting trip, a 65-year-old distraught mother set out alone to find aim. After an aganizing four-mile hike through the fields and forest, following his tracks, she found him—lying dead on an old woods road.

Mrs. Anastasia Green, after tracking her Merchant Marine son in four inches of snow yesterday, came upon his body lying face upward less than a half mile from home. The trail had led her over a four-mile circuitous route.

Died Instantly

The victim, Peter Paul Green, 26, had died instantly when the upper part of his head, above the right eye, had been laid open by the close range blast of a 12-gauge shotgun, officials said.

Dr. Earl J. Gage, Belknap county medical referee, issued a tentative verdict of death by accidental gunshot wound. The investigation is continuing.

How the elderly mother accomplished the task of locating her son alone amazed investigators, because of difficulty with her legs which makes walking any distance an extreme hardship. Investigators theorized that the great concern felt for her son's safety undoubtedly gave her strength for the long trek.

Home for Visit

Peter came home Tuesday evening on a brief visit, his mother disclosed, and was to have returned to New York City Friday. He was a first class engineer on the Sir Franklin, a vessel operated by the Isbrandtsen Co., Inc. He had been a member of the Merchant Marine for nearly 10 years. Authorities said that he had borrowed an automobile from a staff officer on his ship with which to make the trip here alone.

"Peter left here about 3 o'clock Thursday afternoon," his mother related. "taking a shotgun which had belonged to his father, who died nearly two years ago. My son had used his own rifle on a rabbit-hunting trip Wednesday, but he said Thursday, as he started out again that "it was no good, and he took the other gun instead."

Her son had done a lot of hunting, the mother said, and was accustomed to handling fire-

Starts To Worry

When he did not return at dusk, she became worried, especially after hearing a shot about 4 p. m. She did not feel undue alarm, however, because of the knowledge he was well acquainted with the surrounding territory, and thoroughly versed in handling of guns. Her fears began to mount when time passed and he did not return.

Early Friday morning, as soon as it was light enough to distinguish the tracks made by her son in the snow, Mrs. Green started out in search of him. Accompanying her was the family dog, Micky, who reportedly had also acted as companion for young Green the day before.

After circling around in a wide arc—estimated by investigators to be nearly four miles—she came upon Peter's body sprawled on his back, partially on the right

side.

Picked Up Gun

Speaking calmly, but with obvious effort, Mrs. Green related how she quickly realized what had befallen her son, found that he was beyond aid, took the shot gun from beside her son, where it had fallen, gathered a few papers from his pockets, and trudged back home. This was a distance of less than a half-mile authorities said.

Mrs. Green then hurried a quarter-mile further to the home of neighbors, Mr. and Mrs. Konstant Shlaitas, who called Laconia police and the Belknap county sheriff's department. State Police were also notified.

The Green home is situated on a side road, about one mile from Route 107 in lower Gilmanton, and nearly 12 miles from La-

The body was examined by Dr.
Gage at the spot in the woods
where found by the mother. It
was then placed on a stretcher

and carried to the road by four men, Konstant Shlaitas and Robert Publicover, neighbors, and Arthur Simoneau and Hercules Lapointe, both of Laconia. It was removed to the A. W. Simoneau and Son Funeral home in Laconia.

Taking part in the investigation were State Trooper Joseph Bednarz, Belknap Solicitor Thomas P. Cheney of Laconia, Sheriff Homer L. Crockett and Deputy Sheriff Rodney S. Brockett, both of Belmont, and Dr. Gage.

Cause Not Determined

Solicitor Cheney said that while exact facts on what happened may never be known, officials theorized that the dog, Micky, may have been responsible.

Investigation determined, the solicitor said, that young Green was apparently standing in the woods road at the time, after having spied some rabbit tracks, and took up a waiting position. This was evidenced, he said, by a partially smoked cigaret found beside the body.

During their investigation Friday, Mr. Cheney said, officials found the dog would jump upon one quite readily, and felt this is what may have happened to the shooting victim. It would have taken but little to have thrown Green off balance by such unanticipated action of the dog, he said, causing the weapon to discharge.

Green may also have momentarily lost his balance by some other means, Cheney stated, although the dog angle appeared more likely.

Attended Pittsfield High

Peter was born in Randolph, O., on March 28, 1927, son of Peter and Anastasia Green and the family came to Gilmanton first in 1938, the mother disclosed. The son attended Pittsfield High school, and later Cambridge, Mass. High when the Greens moved there in 1943.

He enlisted in the Merchant Marine at the age of 17½ and finished his high school studies in that branch of the service. He was a member of Laconia lodge of Elks.

GILMANTON A tentative verdict of accidental death was given by Dr. Earl J. Gage of Laconia. medical referee of Belknap county, in the death of Peter P. Green, Jr., 26, fatally wounded by a blast from a shotgun he carried rabbit hunting in woods near his home off Route 107 Thursday afternoon.

The investigation is still open as the authorities are awaiting the arrival from New York today of a man who telephoned that he was coming to give some light on the shooting.

Mr. Green, a first engineer in the Merchant Marine service, arrived home Thursday. He was found by his mother, Mrs. Anastasia Green, who went in search of him when he failed to return home from hunting Friday morning. Mrs. Green found her son after starting out at davlight and following his tracks in the snow.

Found in Field

He was lying in a field nearly a mile from his home and Mrs. Green rushed to the house of her neighbor, Mrs. Konstant Schlaitis to seek help. Mrs. Schlaitis called the State police who informed the Belknap county authorities and dispatched State Trooper Joseph Bednarz to the scene.

The police reported there was a small Spitz dog at the scene. They theorized the dog, which was very nervous, might have jumped on the man catching on the shotgun in some manner and discharging the 12-gauge weapon.

First Day on Leave

Green was thought to have been on leave from the SS Sir John Franklin, the ship on which he was serving at Christmas. It docked in New York and is believed to be a tanker of the Esso Oil company. He had been in the service several years. He drove home in a car registered to Ivan Lewis of 136th St., Flushing, L.I.

Mr. Green is survived by his bert cemetery in Laconia. mother. His father died two years ago in the Gilmanton home. The son was in Far East waters at the time, sailing from Singapore and his mother was unable to reach him. He was the only child. Mr. Green was married to Janet Jenson of Everett, Mass., and his mother said she believed he was the father of a son. The couple had since been divorced.
