Philip E. McIntyre of Gilmanton, NH, passed away on September 19, 2013, at his current residence in Laconia, NH.

Born on August 2, 1930, in Randolph, VT, Phil completed his high school education in Randolph. He was an Eagle Scout. He graduated from Norwich University in 1953 with a bachelor of science degree in civil engineering. He married Marion Joan Sawyer on December 27, 1953 in Randolph, VT. In 1955, he received his master of science in civil engineering from the University of Virginia while employed by the Virginia Highway Department as a research assistant in the Charlottesville Laboratory. He served as an enlisted officer in the U.S. Army from 1955 until 1957 stationed at Fort Belvoir, VA, and Fort Leonard Wood, MO. Phil had a 30-year career as a Civil Engineer in the Materials and Research Division for New Hampshire's Department of Public Works and Highways, where he directed and supervised research, laboratory testing and in-the-field inspection program of materials utilized in constructing New Hampshire's bridges and highways. He also was employed for three years by the Asphalt Institute as the District Engineer for New England and Pennsylvania. Registered as a professional engineer in Vermont, New Hampshire and Massachusetts, he was a member of the American Society of Civil Engineers, the American Society of Testing and Materials (new England Council), and was a past secretary of the New Jersey, New York and New England States Testing Engineers. He served as the Director of the New Hampshire Good Roads Association and held membership in several civil engineering honorary societies. All of his life, he enjoyed deer hunting and the outdoors in Stockbridge, VT, at his camp in Stony Brook. In recent years he earned his ham radio license as he spent his last 14 winters in Zephyrhills, FL. He and his wife Marion lived in Gilmanton, NH, for 65 years and while there, Phil served on the Board of Selectmen and as Commissioner of the Fire Department. In October of 2012 Phil and his wife moved to the Taylor Community in Laconia, NH, upon the diagnosis of a malignant glioblastoma.

Phil McIntyre leaves his wife of 60 years, Marion, a brother, Kenneth of Leesburg, VA, (six nieces and nephews), his daughter Dr. Susan McIntyre (Dr. Robert Hollon) of Eau Claire, WI, his daughter, Sara Poisson (Paul) of Claremont, NH, 4 grandchildren (Jesse, Holly, Heather, Hillary) and one great grandchild (Dominic).
