**Z 23-01:** The David J Chandonnet Family Trust, owner, is seeking a variance from 305.14 Lot/Yard Requirements, to add a second level/story to the existing single-family house. Though the proposed second floor addition will be within the footprint of the existing house, the increase in height is considered a vertical expansion within setbacks. #### CAUTION TO RESPONDENT

It is very important that you personally appear in this Court on the date, time and place provided in this notice. If you fail to personally appear, you will be defaulted and will waive your right to object to any findings made by the Court and orders issued, including but not limited to those made and issued as follows:

- At a Preliminary Hearing, the Court will determine whether there is reasonable cause to find your child(ren) is(are) abused/neglected;
- At a Notification of Rights and Consequences hearing for a non-petitioned parent, the Court will inform the parent about the impact of a finding of abuse/neglect on their parental rights;
- At an Adjudicatory Hearing, the Court will determine whether there is sufficient evidence of abuse/neglect of your child(ren) and if so, will make a finding and schedule a dispositional hearing; and
- At a Dispositional Hearing, the Court will issue a final order of abuse/neglect and issue orders for the conditions of abuse/neglect that must be corrected by parents.

Further, by failing to appear you will not be able to provide the Court with your current address, and thus the Court will have no ability to notify you of subsequent RSA 169-C hearings.

##### IMPORTANT RIGHTS OF PARENTS

WHETHER YOU ARE A PETITIONED OR NON-PETITIONED PARENT, IF THE COURT DETERMINES, OR HAS DETERMINED, THERE IS EVIDENCE YOUR CHILD(REN) IS(ARE) ABUSED/NEGLECTED, THE COURT'S ORDERS WILL AFFECT YOU AND YOUR CHILD(REN) AND MAY AFFECT YOUR PARENTAL RIGHTS, INCLUDING THE POSSIBILITY THAT YOUR PARENTAL RIGHTS MAY BE TERMINATED. THE POSSIBLE CONSEQUENCES TO YOUR PARENTAL RIGHTS MAY BE REVIEWED BY CLICKING ON THE COURT FORM, "Acknowledgement of Possible Consequences to Parental Rights in Abuse & Neglect Cases" (NHJB-2209-F) at [www.courts.nh.gov/cour-courts/circuit-court/family-division/forms/luvenile-abuse-and-neglect](http://www.courts.nh.gov/cour-courts/circuit-court/family-division/forms/luvenile-abuse-and-neglect).

Once you appear, you have the right to oppose the proceedings and to present evidence. Pursuant to RSA 169-C:10, I(a), a petitioned parent has the right to an attorney, and if such parent cannot afford an attorney, an attorney will be appointed by the Court. The Court has the discretion to appoint an attorney for a non-petitioned parent who is a household member, if such parent cannot afford an attorney. In either of these circumstances, please contact the court to obtain a financial affidavit if you wish to request court-appointed counsel. The Court has no statutory authority to appoint an attorney for a non-petitioned parent who is not a household member, however such parent may hire their own attorney.

Additional information may be obtained from the Family Division Court identified in the heading of this Citation.

If you will need an interpreter or other accommodations for this hearing, please contact the Court immediately.

Please be advised (and/or advise clients, witnesses, and others) that it is a Class B felony to carry a firearm or other deadly weapon as defined in RSA 625:11, V in a courtroom or area used by a court.

## Kick off meeting to launch environmental study of the Wolfeboro Bay watershed on February 28

WOLFEBORO — The Lake Winnepesaukee Association, in partnership with the Town of Wolfeboro, the New Hampshire Department of Environmental Services, and FB Environmental Associates, will hold a kickoff meeting to present an overview of a study to assess the threats to water quality in the Wolfeboro Bay watershed on Tuesday, Feb. 28. The meeting will be held in the Great Hall, Town Hall, 84 South Main St., starting at 4 p.m. Anyone who lives in Wolfeboro, Alton, New Durham, or Brookfield is encouraged to attend.

The background, scope and timetable for the environmental study will be presented at the meeting. The study will result in a watershed management plan for Wolfeboro Bay that will capture a snapshot of the health of the waters in the bay, identify sources of pollutants in the watershed and provide a roadmap for mitigation and protection efforts which will improve existing lake quality, aquatic habitat, and protect the value, uses, and beauty of the Wolfeboro Bay watershed for the future.

This project is designed to complement the many watershed plans

already completed for other waterbodies within Wolfeboro. In addition, it builds on more than 10 years of effort by the Lake Winnepesaukee Association to develop a comprehensive lake-wide management plan for Winnepesaukee, and is a continuation of a community-based watershed planning process to improve and protect all of the water resources within the lake's watershed. As a major economic asset and outstanding natural resource for the local communities, it is extremely important to assess the threats and issues affecting the lake's health.

The mission of the Lake Winnepesaukee Association is to protect the water quality and natural resources of the lake and its watershed now and for future generations.
