March 11th 1876

Quarterly Report of the Preacher in Charge of Gilmanton to the Gilmanton Quarterly Conference held at the Church March 11, 1876. Number of Sunday schools within the bounds of the charge – one. State of the Sunday school within the bounds of the charge.

With regret we approach this of all others the most important subject. I wish I could report both, increase in interest and in numbers, but present condition of things will not justify. There is chance for great improvement both in interest and numbers, there are many who come to meeting, and are not asked to come into the Sunday school. I wish this could be different. The traveling has been very unfavourable, some Sabbaths not any meetings, consequently not any Sunday school. Average attendance - 18.

Financial Matters

We have subscribed in material and money \$181.00 for the building of a society tent on the camp meeting ground at the Weirs., some of the lumber is sawed and some of the money ready. The building is contemplated early this spring. A debt assumed two years and a half ago by 4 of the Brethren for the Society principle and interest of \$124.00. Money expended on the Parsonage is being () by subscription and the subscription paper is in good hands and we have no doubt will be made satisfactory. The debt long standing of \$12.18 for stove has nearly all been paid.

I think we can safely say that our social meetings are better attended, both class and prayer meetings have increased in number and interest. The first class we attended on coming into the place was class No. 1. It was a pleasant eve. We had six. Last Saturday eve we had 23. Class No. 2 has held its own well. Though good Brv. Hutchinson the class leader has been garnered to the Lord.

Our first prayer meeting on coming to this place a pleasant eve. We had 25. Some evenings we have had less especially when it has been unpleasant but our numbers have increased to 40, 60 & 80. Last Sunday Eve there were nearly 200 but we have been having extra meetings assisted by some Brethren of the Y.M.C.A. with good results. For we think there have been 2 hopefully converted to God. A number reclaimed and others anxiously inquiring the way. There is a prayer meeting sustained in Bro. Richard Jones district every Sunday eve with good results. The Tuesday evening prayer meeting has increased in number and interest. We are at peace with the other demonimations all working unitedly in the one grate cause. All praise be given to the great head of the Church.

We report our Sabbath School in a prosperous condition and yet we are unable to state how it compares with its past history. A good degree of interest marks the sessions of the school. Perhaps there might be more diligent study of the scriptures then is manifest at present, but some are evidently striving to become familiar with the word of the Lord. I have preached once to the children during the Quarter. Received into full membership – none. Excluded from the Church – none. Received by letter one Edina L. Leet. Dismissed – none. Deceased – none. Withdrawn from Church – none. We have been visiting from house to house among our people as we have been able. Not all have been visited. Many are some distance away and we have not been able to reach them yet. A class meeting started with has been held Friday evening at the parsonage. We trust it will be sustained. Prayer meeting is held Sunday at the Church and has been well attended thus far. The Sunday noon class is also held. We have done but little in the out districts of the charge. We regret this but having no team are unable to do as we would. A collection was taken on Childrens Day which amounted to One Dollar Sixty Two cents (\$1.62) for which we hold the receipt of D.I. Kidder.

Year of storms has decreased the numbers of those in attendance on the public service on a few occasions but generally speaking there has been about the same attendance as during the previous report of the year. There is need of greater earnestness in improving the social means of grace. Received into full membership one Bro W.J.D. Sanderson. Excluded – none. Received by letter – none. Dismissed by letter one Laura Partridge. Deceased during the quarter two Sister Sally Currier Bell asleep in Jesus Nov 24 1882 and Sister Lydia Bean departed to be with Christ. None have withdrawn from the Church. Much needed improvement of church property has been partly realized in the shingling of some of the horse sheds in the rear of the Church. I have preached once to the children during the quarter and frequently have given brief talks on the Sunday School lesson. No changes have occurred in church. Membership excepting one death. Sister Sally Pulsifer was called home during the time of the session of the annual conference. Quite a number of our aged members have fallen during a little more than a year. Chose for Trustees R.H. Jones, S.S. Moody, N. Pulsifer, A.F. Rogers, L.W. Downing, E. Varney, A.A. Jones, H. E. Marsh, N. B. Sanborn. Chose L.W. Downing to collect the money due the sexton. The minutes were read and approved.

Aug 10th 1889

The 2nd Quarterly Conference of the M.E. Church was held Aug 10th 1889. Members present P.E. G.W. Norris, Preacher in Charge A.B. Russell, Stewards L.M. Downing, M. E. Downing, G.S.P. Sanderson, Trustees A.A. Jones.

Report of Preacher in Charge read and filed for record. Voted to adjourn until the close of service Sunday. W.S.P. Sanderson, Sec'y.

Aug 11th 1889

A.A. Jones presented a report of \$102 for painting the church and parsonage on which there was a deficit of \$13.24. Voted to apply the unused money raised for lamps towards paying the balance. The adjourned meeting of the 2nd Q.C. was held in the parsonage Aug 11th 1889.

Members present P.E. G.W. Norris, Preacher in charge A.B. Russell, Stewards L.W. Downing, A.F. Rogers, S. S. moody, Mrs. Pulsifer, Mrs. Downing, G.S.P. Sanderson, Trustees N. Pulsifer, A.A. Jones. he estimating committee reported the preacher claims \$500 of which \$75 to be for the parsonage. Report of committee adopted. Minutes read and approved.

Pastor 2nd Q. report for 1889. Financially and spiritually we are able to report some success during the past quarter. The congregation has enlarged though we cannot say as much of the Suinday School. We have not, until within a week had a prayer meeting at the church owing to having no proper facilities for lighting. But our class meetings have been quite well attended and spiritual. There are two Sunday Schools within the bounds of the charge. The one at Jones' Mills is quite flourishing, and there is a very good spiritual interest there. There has been about \$100.00 laid out on the church property; \$50.00 of the sum was given by boarders at the hotel who made this generous gift for the purpose of painting the woodwork of the church and parsonage. Through the kind generosity of my friend John Tilton of Nashua, we have these lights at the expense of \$50.25 to the owner. This leaves \$17.50 collected for that purpose to be expended in other directions. We have raised \$60.00 as the result of an entertainment through the exertion of our young people; the success of which was largely due to the kindness of strangers from abroad who are either boarding or have summer residences here. I have ordered at my own expense two dozen Songs of Joy and Gladness for the use of our young people and others who are inclined to assist in singing at our social meetings. Our situation is exceedingly unfortunate in that our people are so scattered and reside at such distances from the church. This makes our social meetings uncertain and thinly attended at best, but we think that a thorough reformation would improve the state of things greatly. Deep, solid, sound

Christian principle is the need of the hour. Our receipts up to date amount to about \$75.00. We are hopeful and trustful looking to God, who is able to do all things, after me faithfully do what we are able. Gilmanton, NH August 10, 1889

Rogers and Mrs. Anna P. Durgin were chosen stewards. L.W. Downing, S. S. Moody, N. Pulsifer, N.B. Sanborn, R.A. Jones, H.E. Marsh, A.A. Jones were chosen trustees. Committee on Temperance, Anna Durgin, A.A. Jones, N. Pulsifer. Education, A.A. Jones, Carrie Jones, Bertha Pierce. Committee on Missions N. Pulsifer, L.W. Downing, R.H. Jones, A.F. Rogers, Sunday Schools, A.F. Rogers, Bertha Pierce. Church Records, A.A. Jones.

Committee on Parsonage & Furniture, Martha Jones, Marths Downing, Anna Durgin. Committee on Music, N. Pulsifer, A.A. Jones, Carrie Jones, A.F. Rogers. Estimating Committee R.H. Jones, N. Pulsifer, H.E. Marsh. After some expression concerning another year, voted to adjourn at the call of the paster.

The Fourth Quarterly Report for 1890. We see a little light dawning after the darkest night of the history of this Society. For many years the little band has gradually melted away until reduced to the negative quantity. Then the almost fatal year set in which closed the church, and the remnant was scattered. To gather up the fragments has been a task requiring energy and perserverance under difficulties. No inconsiderable part of the whole are hopelessly lost to us. And yet the Lord seems to have been on our side. The financial favors of the past year are remarkable. Fifty dollars in cash from the summer tourists toward painting the church, a fifty dollar chandelier and pulpit. In conclusion I have not given the report a rose color, indeed cannot, nor is the coloring at all dark. There is an aspect of hopefulness brooding the whole. The present condition surpasses our earlier expectations and on a review of the situation we feel to Thank God and take courage.

Pulsifer, Martha Downing, Anna Durgin, Lucinda Pulsifer, and Martha Jones were chosen Stewards. The presiding Elder's pay was raised and paid over.

On motion voted to adjourn.
